Concern: **Complaint of Discrimination**

Dear President,

We are grateful to appear in front of your high personality to address what is mentioned in the concern. Please allow this letter to serve us as our complaint of discrimination against African asylum seekers in BF Peters Waldkraiburg / Camp.

We came to Germany fleeing persecutions in Africa. We are so grateful for the safety and freedom that we have been offered by Germany. Our complaint of discrimination includes the following:

- On the 20th April 2020, the Head of Security abused African asylum seekers that **they are products of the sperms of a monkey.**

We kindly ask the government why they put monkeys (as said by the Head of Security) together with human beings. Meanwhile if they also recognise that African are monkeys, they have to allocate them in appropriate places for monkeys. Otherwise, something should be done for the sake of justice and human rights.

- The rules of safe stay in the camp set that rooms should be checked with respect and help by the person occupying the rooms. Contrarily, the security and some social workers often go to rooms of African asylum seekers when occupants are not around and take their belongings such as money and mobile phones.
- The African asylum seekers identified some social workers who threaten them that they are going to give them problems in this camp. We wonder what kind of social workers they are and yet they segregate African asylum seekers while performing their tasks and duties in the camp.

Being aware that Germany is a country of justice and country which respects human rights, we, African asylum seekers need the government together with all the authorities reading this piece of vital information to come to our rescue by taking the right measures and serving us the justice we are seeking for.

We are not monkeys, we are human beings and therefore we have both rights and duties. We call for rescue!!! WE ARE SEEKING FOR PROTECTION IN GERMANY. Some people in Germany should not torture us psychologically, mentally, physically, emotionally because we are also created in the image of God as it is for all the human beings. Thank you for your continuous assistance!
